*****ELECTION TIME IS HERE, LOCAL BOARD & DELEGATE TO GENERAL ASSEMBLY*****

11/1/ 2015- Appoint local election committee: The Election Committee Chairperson is Laurie Kozisek was appointed by the local board.

11/15/2015- Notice of enrollment requirements: A notice stating the enrollment process and dead line will be by November 15th.

12/11/2015- Post official voting list: Local election officials shall post the alphabetical list of persons eligible to vote in the community by December 11.

12/11/2015- Challenge voting list- Written protest must be submitted to the local elections officials between December 11-16. The chairman shall notify Central Council by December 21.

12/22/2015- Delegate allotment: Delegates per community shall be determined based on voter registry as of December 22.

1/16/2016 ELECTION OF LOCAL BOARD OF DIRECTORS FOR SAN FRANCISCO & NOMINATION OF DELEGATES – Please come if you want to be on the local Board. Address: 2847 Shattuck, Berkeley, Ca. at Noon. Nominations for Delegate for Tlingit & Haida Central Council to serve at the April 2016 General Assembly in Juneau, Alaska. Vote for Delegate will be by absentee ballot.

2/1/2016- Notice of Delegate election: Each local election official shall publish a notice of delegate election no later than February 1, specifying the date of delegate election, nomination of Candidates, and procedures for voting by absentee voting.

1/15-2/5/16- Nominations: Nomination lists must be submitted to central council by February 5. Nominations shall be made at the Board Meeting on January 16. See 1/16/16 above.

2/12/16- List of nominated candidates: A complete list of nominated candidates will be published by February 12.

3/17/16 Election Day - Delegate absentee voting. Ballots must be returned in time to be counted on Election Day.

Submit election delegate report, No later than third Friday March 2016, A written report will be posted as soon as the results are known or no later than close of business the following day. Challenge delegate election, By Monday following delegate election, Written challenges must be post marked within three days of certification and posting of delegate election results and must be addressed to: President, Central Council T&H, 320 W. Willoughby Ave., Ste 300, Juneau AK 99801. Grounds for protest must be listed and substantiating evidence must be included.
